

TOS GAME RULES

REGISTRATION WILL BE AT YOUR GAME LOCATION THE DATE OF THE TOURNAMENT. YOU MUST ARRIVE 45 MINUTES BEFORE GAME TIME. YOU MUST COMPLETE THE FULL PACKET BEFORE YOU WILL BE ELIGIBLE TO PLAY.

NOTE: YOU WILL BE ABLE TO PRE-REGISTER ON LINE.

- 1. Loser Bracket** – Game will be 15 minute half running time.
- 2. Conduct** - Absolutely NO profanity allowed. No hanging on rims. Any fighting on the court will result in ejection for the remainder of the tournament.
- 3. Fouls** – NCAA rules with modifications. Each player will be allowed 6 fouls.
- 4. Game Time** - Eighteen (18) minute halves***Running time***Clock on the time out, last two minutes of second half and at a referees' discretion.
- 5. Uniforms** - Every team must have like colors with numbers. Each team must bring both dark & light color jerseys with numbers.
- 6. Team Roster** - Team rosters must be turned in before game time.
- 7. Grace Period** - There is a 15 min. grace period on the first game of the day only otherwise, game time is forfeit time.
- 8. Playing with Multiple Teams** - Players can only play with one (1) team. Any player confirmed to have played with two teams; player and last team played with will be disqualified from the tournament. It will be up to opposing team to make protest of alleged illegal player and prove their case to tournament director. (Refer to rule 12 for protests)
- 9. Balls** - A team ball can be used if both teams agree, otherwise, TOS ball will be used. Tournament Director will furnish the game ball. Team must furnish practice ball.
- 10. Time Outs** - (1) Full time out and (1) 20 second time out each half. Same applies to overtime.
- 11. Eliminations** - Double elimination tournament with single CHAMPIONSHIP game.

- 12. Overtime** - First overtime will be 3 minutes running clock. Clock will stop for time outs during the last minute and at referee's discretion.
- 13. Protests** - Team protests must be made within one hour after completion of game. In addition, protestors must notify officials at point of protest before the game ends. Protests must be made to the tournament director. Official judgment calls will not be accepted as grounds for protest. A \$150.00 investigation fee must accompany all protests and the money will be returned if the protest is upheld. (Refer to rule 7)
- 14. Timeouts** - Timeouts will not be carried over.
- 15. Technicals**- On any tech, the team must pay \$25.00 per offense. This fee must be paid to the gym head before next scheduled game or team forfeits that game. If the tech is called during an elimination game and the game is lost, the money owed from the tech will be assessed to next year's entry fee. Any player or coach who gets three techs for the tournament will not be allowed to participate in the event.
- 16. Coaches Meeting** - Each team must have a representative at the coaches meeting on Friday, one day prior to tournament. Read participation letter for time and location.
